Some things to consider

Environmental assessment can cost anything up to R100000, we've had a couple of quotes done for our factory and they are in the region of R250000 although ours are for more complicated than this I would imagine

If the plant is fully automated the staff working there would be qualified technicians etc, these people would need a place to live and would be buying in the area, thereby increasing the value of the properties.

My concerns are these:

360000 birds in 6 weeks = 60000 birds a week = 8600 birds a day. Assumption of 1000 birds a truck = 9 trucks a day = 1 truck per hour......that's just to take birds away, would also need to consider feed trucks, manure trucks, birds that getting carted away that die before fully grown etc etc.....can the roads handle this? Do we want this type of traffic in the area? Also need to remember birds being

brought in in week 1, so you can double this figure. If you can only fit 500 birds to the truck you can then double it again....4 trucks per hour, 7 days a week

While the crime may decrease due to employment in the area by the poultry farm, while construction is underway it may increase as labour would have to be brought in from other areas to do the actual construction. That is a lot of opportunity crime if you have 100 people busy with construction.

Don't know how much a chicken drinks but on 500ml per day that is 180 000l a day....think this figure is conservative on my side, if borehole water is used for this all the other borehole owners are going to have no water as the water table drops.

My major concern however is how quietly this has been kept until now, no public consultation, even local estate agents only heard about it on the 13<sup>th</sup> Feb 2013, if there was nothing to worry about, why the silence?

While WFF is considered an agricultural area this is not small scale agriculture, this is a factory / business with high volumes of product; despite this and all the facts above, I think it best to wait until we have all the facts and figures before this project is killed completely, there may be benefits to the area that we could miss out on by objecting before we know all the facts. (although I am struggling to see what they may be)
